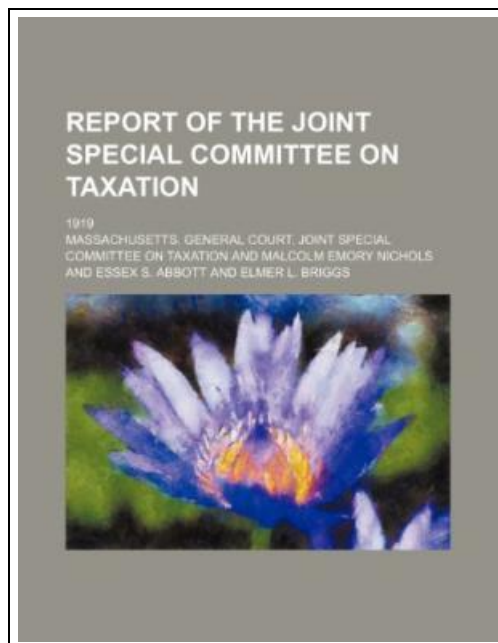

Colonization is now at an end, since intangible property can no longer derive any benefits from it. The taxation of incomes is at the same rate throughout the State, regardless of the domicile of the owner. I therefore hope that no hasty or insufficiently considered method or experiment will be tried out, which, although promising to equalize taxation, will put a premium on extravagance, retard the progress of many thrifty towns and cities, and place additional burdens upon the real estate.
