Recent investigations of the interrelationships among heat flow, ground-water circulation, active faulting, volcanism, and geo-chemical fluid-rock interactions suggest that the Earth Science community is on the verge of developing a new, comprehensive understanding of geothermal sys-tems. The resulting models for the nature and extent of geothermal systems would not only improve the accuracy of any new assessment but also enable the development of more economical exploration and development strategies for geo-thermal energy.
