

Also, worldwide emphasis on environmental problems of air and water pollution and global climate change, and the related development of clean energy technologies in western Europe and Japan, may remain important influences on renewable energy policymaking. Concern about technology competitiveness may also be a factor in debate. For DOE s FY2003 Renewable Energy Program, the Bush Administration sought \$407.0 million, an \$11.3 million (3) increase relative to the FY2002 appropriation, not accounting for inflation. In the 107th Congress, the House Appropriations Committee recommended \$396.0 million for the FY2003 Program, which is \$11.0 million less than the request. In contrast, the Senate-passed version of the FY2003 Omnibus.
