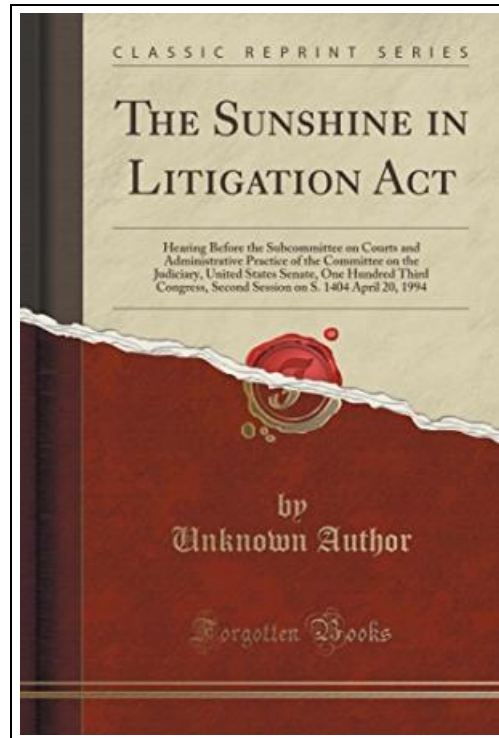

Professor Jack Friedenthal, Dean of the George Washington University National Law Center, is author of the pre-eminent case book on Civil Procedure. And Professor Charles Clausen, from Senator Kohl's home State of Wisconsin will offer his insights on the issue. Finally, we will hear from some individuals who have been parties to lawsuits which involved some type of protective order. While their stories will be very compelling and critical for this subcommittee's deliberations, it is important that we not rush to judgment on the basis of these individual cases. There are no doubt, other cases of individuals who want their privacy protected, whether it is because they may be HIV-positive, or because they had a medical procedure which they don't want the public to know, or because, perhaps, they were under the influence of drugs or alcohol when a serious accident happened. Privacy is a complex issue and must be examined carefully and thoroughly before taking away the right of any litigant to maintain it. My own record on the issue of Government secrecy and accountability is one I will stand on: Whether it is exposing fraud on the Government by those who would do business with the Government or forcing Congress to live by the laws it writes for everyone else. But there is a big difference between making sure the Government's business is done in...
