

This is of no value for lack of consideration. 323. Kinds.--Warranties are either expressed or implied, and in reference to the thing warranted, are either of title or of quality. 324. Warranty of Quality.--Whether a statement made at the time of sale will amount to an express warranty or not depends, as we have said, upon the circumstances of each case. If there was a serious defect covered by the seller s statement, and one peculiarly within his knowledge, and not open to the buyer s inspection, it will have great weight in deciding his statement to be a warranty. But it must be remembered that Caveat Emptor is the general rule and that these are only exceptions or modification of it. 325. When Warranty of ftuality Is Implied.--When the buyer is not permitted to inspect the goods, or where inspection from the nature of the case is impossible, the rule of Caveat Emptor does not apply, and a warranty is implied. This is the case when goods are sold by sample or description. When goods are ordered for a particular purpose, and the buyer must necessarily rely...
