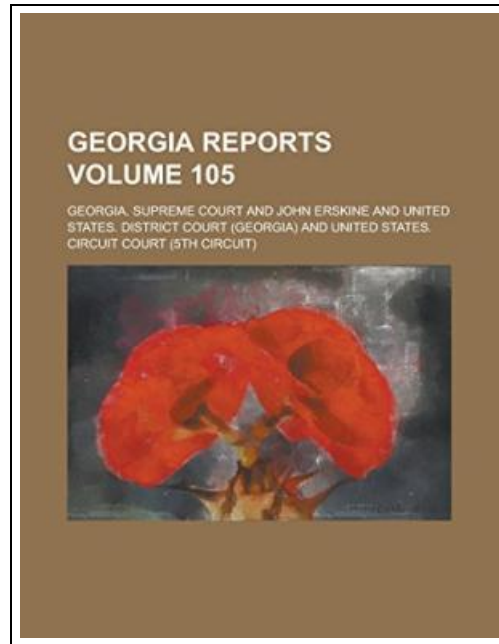

Excerpt: .evidence in the present case, the county judge was warranted in finding that the accused was not protected by the 1 -bV mentioned clause of the constitution of the United States, and that he was a party to such a scheme as that indicated in the Preceding headnote. Accordingly, there was no error in refusing, on certio rari, to set aside the conviction of the accused. Judgment ayfirmed. All the Justices concurring, except Cobb, -7., absent, and Lew-is, J., disqualified. Argued March 21, - Decided April 11, 1898. Certiorari. Before Judge Callaway. Greene superior court. The accusation on which the plaintiff in error was tried in the county court charges, that in Greene county, on the 16th and 17th of August, 1897, he unlawfully peddled clocks and carried on the business of a peddler of clocks, before registering his name and place of business with the ordinary of the county as required by law, and before paying the tax for the fiscal year 1897 to the tax-collector of that county as required by law. The testimony at the trial showed, that on August 13, 1897, a man other than defendant sold clocks in Greene county to various persons at the price of \$9 per clock, to be paid for in instalments of \$1. On the 16th of the same month defendant delivered the clocks, receiving from each of these buyers \$1, and giving each of them a receipt written upon a blank..
