

This court has exclusive jurisdiction in the review of civil actions and criminal cases appealed from the Appellate Division of the Supreme Court. The Appellate Division of the Supreme Court may allow an appeal to the Court of Appeals upon any question which in its opinion ought to be passed upon by this court. This court may finally determine actions, and may give orders granting new trials, but it is limited to a review of questions of law, except where the judgment in a criminal case is for death, in which case the court can review the facts as well as the law. It is the highest court of original jurisdiction, OF THE STATE Established by the Act of 1847, and since altered under Acts of 1857 and 1878. and is composed of 76 justices. They are elected at the general election, and paid from the State Treasury. This court has general jurisdiction in law and equity. It is divided into three branches called the Appellate Division, the Trial Term, and the Special Term. For the administration of justice, through the Supreme Court, the State is divided into eight Judicial Districts, and Trial and Special Terms are appointed in each District. The divisions are by counties, and the Districts of the State are numbered as follows: --1. New York county, with 22 justices. 2. Richmond, Suffolk, Nassau, Queens, Kings, Westchester, Rockland, Dutchess, and Putnam counties, with...
