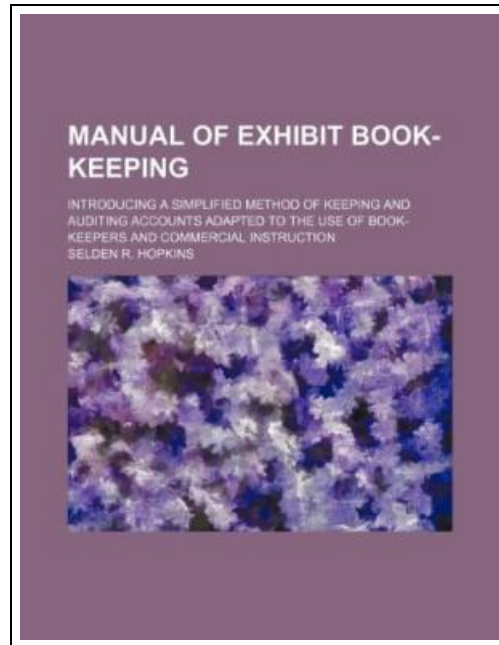

All subsequent entries made in the books, bearing upon the proprietary interests, will, in this case also, be taken as equally competent....
